SUPERINTENDENT COCHRAN'S REPORT:

- ★ COVID
 - Minimal level in the community. Rolling average continues to hover around 1 or less.
- ★ Building Update
 - Sealed bids for the Student Support Center were due November 1st. Four bids were received. The high bid was \$150,100. Other bids included 50,107, 25,000, and 10,000. The highest bidder has paid earnest money of \$15,000 and has 45 days to close the property. Deal will move to the second highest bidder if bidder one is unable to complete the deal.

 - Chart provided from JCI and architect from BMS Development
 - Survey issues Surveyor has left job
 - Maximum price to be presented in April
 - On track to break ground in April 2022

★ Bus Routes

- Drivers continue to be a concern. We anticipate not being able to run some routes in January. City routes would be the first consideration in hopes that many are close enough to walk to school.
- We are still evaluating options to entice employees to drive
- A referral bonus was put in place (\$500.00). We have received three drivers under this incentive.
- Daily pay for drivers in being evaluated to see what we can do to make it more attractive

★ RFP (Request for Proposal)

The BHS track resurfacing was submitted in an RFP due to the cost of the project and State Law. It has been advertised for 28 days and bids will be submitted in December in hopes to complete the project by the end of January.
